Course Aim

To provide the basic knowledge and skills of Occupational Health and Safety legislative requirements, principles of risk management and the prevention of injury and illness in the construction industry.

Why attend?

People working in the construction industry need proof that they have completed a general OHS induction for the construction industry.

Who should attend?

- Anyone carrying out construction work including site supervisors, surveyors, trades persons and labourers.
- Anyone with access to operational construction sites unaccompanied or not directly supervised by an inducted person.
- Anyone whose work role requires them to routinely enter operational construction sites.

- Identify Construction Hazards and Control Measures
- Identify OHS Communication and Reporting Processes
- Identify OHS Incident Response Procedures

Evidence of Identity (EOI)

- A 100 point EOI check is undertaken for each participant prior to commencement of training
- Special provisions for the School Sector, Correctional Centres, Aboriginal and Torres Strait Islanders and overseas persons recently arrived in Australia (less than 6 weeks)

Certification

- Successful participants will receive a Statement of Training (SOT) from the Accredited Trainer
- NSW WorkCover will issue the Construction Induction Card (CIC)
