JUDGING CRITERIA

This Award recognises demonstrated commitment to continuous improvement of workplace health and safety outcomes through the creation and continuation of an outstanding work safety culture. An outstanding safety culture is created through leadership, workforce engagement and training; and reinforced across the organisation using the following:

- Robust safety systems with cooperation and collaboration at all stages of the planning, implementation, monitoring and reporting
- Demonstrated behaviour and workforce engagement
- Symbols such as recognition programs, awareness campaigns and risk management

Excellence in safety culture must be demonstrated at all levels of the organisation, from senior management's commitment to health and safety, to employees' communication and ownership of responsibility.

Free to nominate. Entries close Friday 4 May 2018. Judging will take place in June 2018.
